

**ENNIS TOWN COMMISSION MEETING

**Open Meeting:** Mayor Pine opened the September 6, 2017 Commission meeting at 10:00 a.m.

**Commission Present:** Palmerton, Roberts, Leavitt and Bancroft.

**Resolution 534-2017:** A Resolution allowing the General Fund to borrow \$25,000 from the Water Fund for legal fees.

The Commission reviewed the Resolution. Palmerton made a motion to adopt Resolution 534-2017. Leavitt seconded the motion.

Discussion: Palmerton stated she doesn't agree with this law suit.

Roll Call Vote: Roberts, Leavitt and Bancroft voted yes. Palmerton voted no. Motion passed.

**Resolution 535-2017:** A Resolution setting the Mill Levy for fiscal year 17-18.

Palmerton made a motion to adopt Resolution 535-2017 setting the Mill Levy for fiscal year 17-18. Leavitt seconded the motion.

Roll Call Vote: Roberts, Leavitt and Bancroft voted yes. Palmerton voted no. Motion passed.

**Resolution 536-2017:** A Resolution adopting and approving wages for fiscal year 17-18.

Leavitt made a motion to adopt Resolution 536-2017. Bancroft seconded the motion.

Librarian, Karen Ketchu, said she is really disappointed in the process of setting wages and how they were handled. She wants to get the wages up to where they should be. There was some discussion on this matter. The Commission is to look into this more.

Roll Call Vote: Roberts, Leavitt and Bancroft voted yes. Palmerton voted no, stating she needs more information. Motion passed.

**Resolution 537-2017:** A Resolution of Intent to cancel the November 7, 2017 General Election of Certain Municipal Officers.

The Commission reviewed the Resolution.

Leavitt made a motion to adopt Resolution 537-2017. Bancroft seconded the motion.

Discussion: This is a new law and this is the first year it will be implemented.

Palmerton stated she doesn't like this. She believes in Democracy and thinks there should be an election.

Roll Call Vote: Roberts, Leavitt and Bancroft voted yes. Palmerton voted no. Motion passed.

**Resolution 538-2017:** A Resolution cancelling the November 7, 2017 General Election of Certain Municipal Officers.

Palmerton made a motion to adopt Resolution 538-2017. Leavitt seconded the motion.

Roll Call Vote: Roberts, Leavitt and Bancroft voted yes. Palmerton voted no. Motion passed.

**Adjourn:** Bancroft made a motion to adjourn the meeting. Palmerton seconded the motion.

Roll Call Vote: All Commissioners voted yes. Motion passed.

The meeting was adjourned at 10:30 a.m.
