Palmerton moves to approve. Hankins seconds. Allison abstains, all others vote yes.

Vote on Resolution 569-2022: Annexation of Land to Town of Ennis Boundaries

Discussion on zoning, water and sewer hookup. Ranson moves to approve. Hardy seconds. All vote yes.

Vote to accept and approve 2nd reading and vote to adopt Ordinance #145 (Noise Ordinance)

No public comment.

Palmerton comments against the ordinance, states Town should just use MCA and repeal existing ordinance that is unenforceable. Ranson moves to approve. Palmerton seconds. Ranson yes. Allison abstains. Hankins yes. Palmerton no. Hardy yes. Ordinance passes 3:1.

Vote to accept and approve 1st Reading of Ordinance #147 (Termination of Ambulance Service)

No public comment. Palmerton makes motion to approve. Hankins seconds. Findings of fact submitted – sustainability study. Allison abstains, all other vote yes.

Vote to accept and approve 1st Reading of Ordinance #148 (Lease of Garage Space for Ambulance)

Hardy moves to approve. Ranson seconds. Allison abstains, all others vote yes.

Gift for John Bancroft – gift basket and plaque. Comment made from staff that something should also be done for Town employees after retirement.

Scheduled Matters

Discussion on establishing a Town of Ennis Planning Board- update on interlocal agreement with Madison County Planning Board

Mayor comments on the need for a planning board. Discussion on possible candidates. Commission asks Clerk to post in Madisonian for interested parties.

Renewal of James Greenbaum as the Town on Ennis City Attorney 7-4-4602. Appointment -- term of office. (1) The city attorney must be appointed by the mayor, subject to approval by the city council.

Ranson motions to approve. Hankins seconds. All vote yes.

Review and Vote on Lions Club request for a dog park to be created at the Lions Club Park

Ranson moves to approve. Palmerton seconds. Public comment on the large portion of the park that would be taken up. Commissioners comment against the location and mixed-used parks. All vote no.

Review changes to business license code and fees, date for 1st Reading April 28th at 6:00 p.m.

Review changes from last meeting and plans to bring updates to April 28 meeting for vote.

Resolution to change fiscal year 2021-2022 budget

Ranson moves to approve resolution 568-2022 to change the fiscal year 21-22 budget to increase expenditures in administration, financial, services and ambulance. Hardy seconds. Ranson makes a motion to amend resolution 568-2022 to state Ambulance Fund spending authority shall increase from \$0 to \$51,141 to cover final expenditures that include \$47,729 paid to MVMC as agreed and \$3,412 in unpaid ambulance supply invoices and billing software. Palmerton seconds. All vote yes.

Discussion on repealing and replacing town medical marijuana ordinance with Madison County marijuana ordinance

Attorney Greenbaum gives informal opinion and suggestion for Town of Ennis to adopt the Madison County Ordinance.

Work session set to follow March 28th meeting. Mayor requests Commissioners come to meeting with their homework done on how to move forward with marijuana regulations.

Discussion on item of concern from staff members John Moore and James Greenbaum on legality of anti-camping, homeless sleeping- An area must be designated and civil plan adopted and initiated

Attorney Greenbaum gives summary of the recent court ruling in the 9th Circuit Court Boise vs Martin. The ruling held that cities cannot enforce anti-camping ordinances if they do not have enough homeless shelter beds available for their homeless population.

Greenbaum suggests adopting an ordinance that would define and regulate overnight camping.
