MONTHLY LAW ENFORCEMENT REPORT TO THE ENNIS TOWN COMMISSION

Regular Commission meeting November 10th, 2022.

With winter upon us we have a few reminders for everyone:

- Remove all ice and snow from your vehicle before driving, especially from the hood, windows and roof. If you drive with an obstructed view (MCA 61-9-405) and we catch you, expect a citation. This is a safety issue for everyone on the roadway.
- Turn on your headlights, using low beams when traveling in snow.
- Increase your following distance. In winter weather, travel at least eight to 10 seconds behind the car in front of you.
- Drive slow (at or below the posted speed limit) and adjust your speed for the changing road conditions.
- Give snowplows plenty of room to work. Don't tailgate and try not to pass. If you must pass, take extreme caution in doing so. Remember, a snowplow operator's field of vision is restricted. You may see him, but they don't always see you.
- Snowmobiles may not be operated on the streets or alleyways in the Town of Ennis.
- If you have a sidewalk in front of your business or residence, town ordinances require that owners or operators of a business shall keep their sidewalk clear and free of any snow and ice and they shall keep their sidewalks in good repair.
- Parking a vehicle, trailer, and/or boat on the side of the roadway even in front of your property is not allowed if it is parked for over 5 days.

Windows 10 continues to be a battle with the Bluetooth connection and downloading the speed signs. Sooner or later a work around will be released from Windows or TrafficLogix to get our Bluetooth connection working again and the speed sign reports will continue.
