Regular Commission meeting December 8<sup>th</sup>, 2022.

During the holiday season, people tend to make a greater number of purchases than they do during the rest of the year. They also tend to be more distracted and face an increased risk of theft during the holidays.

Some Holiday (and everyday) tips to prevent theft:

- Lock your vehicle and remove all the valuables. Yes, even in your driveway.
- Make sure all doors and windows are locked at home.
- Place gifts where they can't be seen from the outside.
- Be suspicious of unexpected sales calls or deliveries. Ask for identification.
- Investigate charities before making donations. Ask how the funds will be used.
- Be aware of scams that criminals commit to take advantage of people's generosity especially during the holidays.
- Leaving for the Holidays, ask a trusted friend or neighbor to watch your home. Let Law Enforcement know if you are planning on being gone and have no one to watch your home.
- If something doesn't look right say something to Law Enforcement.
