Please stop in at Town Hall to complete your registration and avoid a potentially unpleasant conversation with the police department. Current proof rabies vaccine is required.

When you park your vehicle in town, it must be completely off the roadway surface. Even if the snow is in the way. You can not park on the roadway and obstruct traffic.

I am still working on getting the Speed Signs to connect and provide data. Windows 10 and Bluetooth continues to be an issue with the speed sign program. According to Windows it is the sign program and according to the sign program engineer's it is a Windows problem. Someday we may find a solution.
