## **PUBLIC HEARING**

The Ennis Town Commission will conduct a public hearing on Thursday, December 11, 2025, at 6:15 pm in the Ennis Town Hall at 328 West Main St, Ennis, Montana. The Commission will consider the following agenda item and will take action upon a resolution of intent.

The Ennis Planning Board have completed an updated Ennis Growth Policy and have voted to recommend adoption of said Growth Policy to the Town Commission. The Ennis Growth Policy is a long-range plan, meant to help guide land use decisions and focus the community's vision for the next five years. The growth policy is not a regulatory document and cannot be used solely to make decisions on proposed land use projects or development, but it is the necessary foundation for all other land use regulations.
